Notes from the District Administrator

We have had the most unusual start to our school year. There were many changes and some time was needed to make adjustments, but overall, we've settled into a routine with teaching and learning underway. Here are some highlights:

- We began school offering both an in-person option, which is traditional learning, along with a virtual option, or online learning. We have a total enrollment of 363 with 58 enrolled in our virtual school option.
- On September 28th, the Board of Education approved a change in our weekly schedule to reduce in-person instructional days to four days per week with Fridays being virtual instructional days for all students. The purpose of this change was to provide more planning time for teachers as they have had more demands placed on them balancing the in-person learning model along with the virtual learning model. The change was approved to begin the week of October 12th and the Board will review the situation at their regular meeting on November 18th at 6:30 p.m. in the auditorium.
- As I write this on September 28th, we have had 6 individuals test positive for covid connected to our school and 25 individuals test negative. In 3 of the situations, we were not required to do contact tracing as the individuals had no exposure to anyone in school. Of the other 3, we did conduct contract tracing and individuals identified as close contacts were under quarantine. Numerous individuals identified as close contacts were tested, and at this point in time, all those who were tested and received results, received negative results. This is constantly monitored and can change at any time.
- Our fall season of sports has been sporadic. We had a delayed start, but then began football and volleyball at the middle and high school levels. We had some interruptions with some players out for quarantine purposes, but the seasons will continue as normal as quarantine directives expire in early October. We need to limit the number of spectators this fall. Each volleyball player received two tickets for indoor spectators and each football player received four tickets for outdoor spectators.
- Homecoming will look differently than our traditional week of activities and events. Student Council is working hard to plan safe activities to support school spirit. We hope to have festivities the week of October 12th.
- Parent/Teacher Conferences will be all virtual this year. Teachers will be arranging conferences with parents by phone call, through Google Meets, or through email. The conferences may take place at other times than indicated on our school calendar.

Thank you for being supportive of our school community and for understanding our need for flexibility. Each day can bring change and we may encounter situations in the near future that will take us down a new path. Watch our school website for updates and district news.

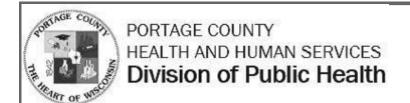

Testing for COVID-19 is available across the state and locally through healthcare systems. See the resources below to find testing near you.

Local

 - Complete the online COVID-19 screening tool or call your Ascension physician's office.
 - Call the toll-free helpline for questions: 833-981-0711
 - **NOTE:** COVID-19 tests at Ascension facilities are only available following receipt of an order from a medical professional. COVID-19 test orders are not available through the toll-free helpline or Ascension Online Care.
- Aspirus
 - Call the COVID-19 Call Center: 1-844-568-0701
 - Hours: 7 a.m.-7 p.m., Monday-Friday | 8 a.m.-5 p.m., Saturday-Sunday
- Marshfield Clinic
 - Call the COVID-19 Nurse Line at 844-342-6276 for an appointment for COVID-19 testing.

Statewide

• If you received testing at a free Wisconsin-based National Guard Testing site and have been waiting more than 5 days for your COVID-19 test results, call the Wisconsin COVID-19 Results Line at 866-419-6988.

COVID-19 testing is FREE for anyone who is experiencing a symptom of COVID-19 or if they are identified as a close contact by the health department. There are not "out of pocket expenses for getting tested.

If your child starts having symptoms of COVID-19, do not send them to school. Call your heath care provider or one of the providers on the left-hand column. They will be able to guide you on whether a test for COVID-19 is recommended.

Don't have a doctor? You can call any of the providers listed and they will assist you.

Anyone experiencing COVID-19 symptoms should self quarantine (stay home) and call their health care provider.

Symptoms of COVID-19 include:

- Cough
- Shortness of breath/trouble breathing
- Loss of taste/smell
- Fever at or above 100.4 or chills
- Runny nose or nasal congestion
- Sore throat
- Unusual fatigue
- Nausea or vomiting
- Headache
- Muscle ache
- Diarrhea

Reading Nook

How to Help Your Reader

Now that we are back into the school routine and ready to increase success and progress, we need to continue to support our child's reading development.

FACT

By reading more complex books, your child can learn new words, facts, and ideas. Your child will be exposed to more complicated plots and will grow as a reader.

TIP

Knowing something about the topic or setting makes a tougher book easier to comprehend. If your youngster is read a novel set in France, help your child understand that setting by talking with someone who has been there or looking up information about the country (try a safe site, such as: kids.nationalgeographic.com)

GROWTH

Once you have chosen more complex texts, **support your child by having resources such as a pencil and paper** to jot down questions, words to look up, or facts to learn more about. Also, help your child find **simpler books on the same subject** of a difficult text, it will help your youngster better understand and build background.

This year's FPW campaign, "Serve Up Fire Safety in the Kitchen! TM," works to educate everyone about the simple but important actions they can take to keep themselves, and those around them, safe in the kitchen.

- Cooking is the leading cause of home fires and home fire injuries. Thanksgiving is the leading day for fires involving cooking equipment.
- The leading cause of fires in the kitchen is unattended cooking.
- Stay in the kitchen when you are frying, boiling, grilling, or broiling food.
- If you are simmering, baking, or roasting food, check it regularly and stay in the home.
- Always keep a lid nearby when cooking. If a small grease fire starts, slide the lid over the pan and turn off the burner. Leave the pan covered until it's cool
- Keep anything that can catch fire away from your stovetop.
- Loose clothing can hang down onto stove burners and catch fire. Wear short, close-fitting, or tightly rolled sleeves when cooking.
- Have a "kid-free zone" of at least 3 feet (1 meter) around the stove and areas where hot food or drink is prepared or carried.

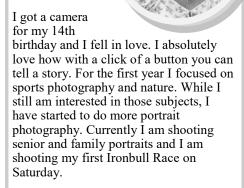

FACE COVERINGS ARE REQUIRED IN THE ALMOND-BANCROFT SCHOOL!

On September 22, Governor Tony Evers issued Executive Order 90, declaring a public health emergency, and corresponding Emergency Order 1, regarding face coverings in certain situations for people over the age of 5.
