
**In 2015-2016, nine juniors and seniors took Advanced Placement exams. Seven of the nine (78%) scored high enough to earn college credit.





















 Applicants that have earned a Gold or Platinum rating are guaranteed an interview. The number of participating employers will continue to increase as more students earn certificates.




FORWARD EXAM: Percent of students at proficient or advanced levels







The completion of the report is projected toward the end of October at which time the Board will certify the levy. Informational: School District Fund Balance

Wisconsin governmental units use a form of accounting known as fund balance accounting. Accounts are summarized on a balance sheet as "Assets", "Liabilities", and "Fund Balance".

The District's fund balance represents:

Total Assets of a Given Fund – Total Liabilities of a Fund = "Fund Balance"

An adequate reserve of assets permits our district to:

- Accumulate sufficient assets to make designated purchases (i.e. roof replacement schedules)
- Avoid excessive short term borrowing to meet expenses, which could result in losses from differences in investment and borrowing rates
- Avoid spending operational funds for interest payments
- Preserve a high bond rating

- A. <u>Section 120.10</u> of the Wisconsin State Statutes requires that every elector of a common or union high school district is eligible to vote at an annual meeting of the school board.
- B. <u>Section 120.10</u> of the Wisconsin State Statutes describes the powers of an annual meeting and designates that the following may take place.

Set annual salaries or a payment based on each meeting attended for board members. Authorize the payment of actual and necessary expenses for board members who travel in the performance of their duties.

Designate sites for school buildings.

Authorize the board to acquire real estate by purchase or condemnation.

Vote a tax for the operation of the school, create a capital expansion fund, and for other purposes, enumerated in s.120.10.

Direct and provide for the prosecution or defense of any legal action or proceedings in which the School District is interested.

Direct the Board to furnish school lunches to district students and appropriate fund for that purpose.

Authorize the Board to furnish textbooks to students under conditions prescribed by the annual meeting or School Board.

Authorize the purchase of vehicles or finance contracts for the use and services of transportation vehicles.

Adjourn the annual meeting from time to time to establish a different date or time for a subsequent annual meeting.

- C. The agenda for the annual meeting is established by the School Board.
- D. Those eligible to vote at the annual meeting must meet the following eligibility criteria:
 U.S. Citizen, age 18 as of October 19, 2016. Resident of the Almond-Bancroft School District for ten days prior to October 19, 2016.

The October 21, 2015 Budget Hearing was called to order by President Debbie Bradley at 6:30 PM.

The budget is a balanced budget this year. We have many factors that contribute to fluctuations in that balanced budget such as heating and electric, substitute costs, etc. We reduced staff and hired less experienced staff which is less expensive. We had no increase in health and dental premiums. Source code 340 includes our open enrollment in dollars. Open enrollment is a huge factor in our budget. State aid has increased by approximately \$66,500. We have Erate Category 2 funds this year. We have to pay first and are reimbursed for 80% of the cost of these projects. The section of instruction 110 000 is elementary, 120 000 is middle school and high school, and 130 000 is career oriented tech education, business education, and FACE classes. In the 280 000 is the expense for the copier leases. 400 000 is the inter-fund transfers that support Fund 27, Special Education Fund, and Fund 50, Food Service Fund. 430 000 includes open enrollment out dollars. Fund 39 is Debt Service. Fund 41 is Act 32, Energy Efficiency. We will fixing the older showers, creating a vestibule for visitors entering the building, working on air handling units, etc. Fund 80 is the Community Service Fund. We are using these funds to fix the stage floor and other community projects. The tax levy is a total of \$1,624,564 for a mil rate of 9.36.

Erika Spear reviewed the WKCE testing scores. We outperformed the state and ourselves compared to prior years in science and social studies for grades 8th and 10th. The ACT testing in 2014-15 revealed that 42% of our testing students were considered ready for college in the areas of English, Reading, Math, and Science. Eight students took the English AP exam and 9 students took the US History exam for college credit. Six out of the eight students who took the English exam earned college credit and four out of nine earned college credit for US History. The next test is named the Wisconsin Forward Exam and at this time it is replacing the Badger Exam.

AMENDED RESOLUTION FOR THE REVENUE LIMIT EXEMPTION FOR ENERGY EFFICIENCY

Be it resolved that the School District of Almond-Bancroft is exercising its taxing authority under s. 121.91 (4) (o), Wis. Stats., to exceed the revenue limit on a non-recurring basis by an amount the district will spend on new energy efficiency measures and energy efficiency products for the 2015-2016 school year and 10 years of debt for the term of the state trust fund loan. The District paid \$65,745 on the state trust fund loan in March, 2016. The amount to be expended as a payment on the loan in the 2016-2017 school year is \$65,633.62. Future year payments are currently scheduled as follows:

After review of the recommendations report per 66.0133(2)(b) the district has determined that the (not to exceed) \$500,000 it would spend on energy efficiency projects recommended in the report is not likely to exceed the amount to be saved in utility costs of \$7,725 and non-utility costs of \$7,550 over the remaining 50 year(s) useful life of the facility to which the measures apply. The board entered into performance contract under s. 66.0133, Stats. with CESA 10 in June of 2015 for a project to implement energy efficiency measures or purchase energy efficiency products and identified cost recovery performance indicators to measure energy savings and/or operational savings for each including the timeline for cost recovery as indicated in the attached chart.

The Board shall annually perform an evaluation of the performance indicators and shall report to the electorate as an addendum in the required published budget summary document per s. 65.90, Wi s. Stats., and in the school district's newsletter or in the <u>published</u> minutes of the school board meeting. The Board shall use this evaluation to determine the amount of energy (utility) cost savings, as a result of the project, that shall be applied to retire the debt.
